AMERICAN FARM BUREAU FOUNDATION FOR AGRICULTURE 2024 GIVING DAY GIFTS OFFICIAL RULES

OFFICIAL RULES: All eligible individuals, as described below, agree to be bound by these Official Rules and by the decisions of American Farm Bureau Foundation for Agriculture ("AFBFA"), which shall be binding and final as to all matters related to AFBFA's 2024 Giving Day Gifts.

NET PROCEEDS: All contributions to AFBFA on 2024 Giving Day will benefit AFBFA and the programs that it supports.

GIFTS: Five (5) donors to AFBFA on October 16, 2024 will receive one of the following gifts: 1) First Gift - 20-Can Backpack Cooler Provided by CAT; 2) Second Gift - 45-minute Virtual Classroom Visit from Award-Winning Children's Book Author, Peggy Thomas; 3) Third Gift - Bundle of Feeding Minds Press Books; 4) Fourth Gift - 30-Minute Consult with Social Media Expert; and, 5) Fifth Gift - 30-Minute Consult with Media Expert. AFBFA reserves the right to change or substitute any of the gifts in its sole discretion. The gifts awarded are "AS IS", and AFBFA and the Released Parties (defined herein) expressly disclaim any warranties, express or implied, including but not limited to the warranties of merchantability and fitness for a particular purpose, relating to any gift in any way. Winners may not substitute, assign, or transfer a gift or redeem a gift for cash.

ELIGIBILITY: Any individual who donates a minimum of Twenty Five Dollars (\$25.00) between 12:00 am and 11:59 pm on October 16, 2024 to AFBFA shall be eligible to be selected to win one of the gifts. Each donation that meets or exceeds the minimum amount set forth above shall qualify as a separate entry; provided; however, an individual may only win one (1) gift. The following persons are NOT ELIGIBLE to win any gift: Employees, officers, and directors of AFBFA, and the immediate family members of such persons. AFBFA shall be the sole judge of the validity and eligibility of all entries.

DRAWING: Potential gift recipients will be selected in a random drawing from eligible entries received (the "Drawing"). The Drawing will be held before October 31, 2024 ("Drawing Date"). The first entry drawn will receive the first gift, the second entry drawn will receive the second gift and so on. The winners will be notified by e-mail pursuant to the contact information provided with their donation. Each winner will have thirty (30) days from the date of the email (the "Claim Date") to claim his/her gift. The odds of receiving a gift depend on the number of eligible entries received. If the potential winner has not claimed his/her gift by 11:59 P.M. on the Claim Date, he/she shall no longer be eligible to win the gift and a new potential winner of that gift will be selected from the remaining eligible entries. The same drawing and notification procedures outline above will be used. If the gift is not claimed by the new date, the procedures in the preceding sentences will be repeated until an eligible entrant properly claims the gift within the proper time constraints.

TAXES: All federal, state and local income taxes are the sole responsibility of the gift recipents. **GENERAL CONDITIONS:** The Released Parties (defined below under "Release of Liability") are not responsible for: 1) donations, payments for donations or any other related communications which are lost, late, incomplete, inaccurate, delayed, misdirected, undelivered, or not fully captured, or 2) any other errors of any kind, whether human or electronic in nature, which relate to or are connected with the donations and gift selections.

RELEASE OF LIABILITY: Gift recipients agree that AFBFA and American Farm Bureau Federation ("AFBF"), and each of their affiliates, and each of AFBFA, AFBF, and their affiliates' respective officers, directors, employees, representatives, and agents (collectively, the "Released Parties") will have

no liability whatsoever for, and shall be held harmless by entrants against, any liability for injuries, losses, costs, expenses or damages of any kind, including damages for death, personal injury, property damage or property loss, resulting from, whether in whole or in part or directly or indirectly, donations to AFBFA or the acceptance, possession, misuse or use of any entry or gift.

GOVERNING LAW; SEVERABILITY: The Official Rules shall be subject to and governed by the laws of the District of Columbia. If a court of competent jurisdiction finds that any provision of these Official Rules, or their application to a particular persons or circumstances, is invalid or unenforceable to any extent, then the remainder of these Official Rules, and the application of all of these Official Rules to other persons or circumstances, shall not be affected by that determination, and shall remain enforceable to the fullest extent permitted by law.
